CALL FOR APPLICATIONS - Academic Year - 2016 / 2017

Master in Medical Imaging Technologies (2nd Cycle) Application call – 3rd Call

1. Number of places:

- 1.1. Total number of places for the academic year: 20
- **1.2**. No of places for this call 12
- **1.3.** Minimum number of enrolments, including all calls, necessary for the running of the Study Cycle: 10

2. Entry qualifications:

- **2.1.** *Licenciatura* level degree, or legal equivalent in any of the following: Radiology and/or Radiotherapy and/or Nuclear Medicine, Biomedical Engineering, Electrical Engineering, Informatics Engineering, Physics Engineering.
- **2.2** Foreign higher education degree in Radiology and/or Radiotherapy and/or Nuclear Medicine, Biomedical Engineering, Electrical Engineering, Informatics Engineering, Physics Engineering awarded on completion of a 1st cycle study programme organised in accordance with the principles of the Bologna Process by a State adhering to this process.
- **2.3** Foreign higher education degree in Radiology and/or Radiotherapy and/or Nuclear Medicine, Biomedical Engineering, Electrical Engineering, Informatics Engineering, Physics Engineering recognised as satisfying the objectives of the *licenciatura* degree by the scientifically and statutorily competent body.
- **2.4.** The Scientific Council of the University of Aveiro may admit applicants proposed by the Director of the Study Cycle who do not meet the conditions specified above but whose academic, scientific or professional curriculum reveal an adequate preparation for frequenting the Masters programme, in accordance with Article 17, N° 1d), Decree Law n° 74/2006, as expressed in Decree Law n° 107/2008, of June 25, and Article 47, N° 1d) of the Study Regulations of the University of Aveiro.
- **2.5** The recognition referred to in 2.2, 2.3 and 2.4 is valid only for entry to the study cycle and does not confer equivalence to the degree of *licenciatura* or recognition of this degree.

3. Selection criteria:

- **3.1.** Applicants for enrolment will be selected by the Selection Board of the Study Cycle, taking into account the following parameters:
- a) Academic curriculum;
- b) Scientific curriculum;
- c) Professional curriculum.
- **3.2.** An interview and / or a written test may be required as complementary criteria.
- **3.3** Sub-criteria and their respective weighting are given in a specific minute approved by the jury for this application, available for consultation at the same location as this Call for Applications.

4. Admission of applicants:

- **4.1** Applicants will be placed by the Admissions Board for the call, taking into account the order of preference indicated by the applicant for each study cycle and the order in which the applicant has been placed in each of the study cycles by the Selection Board.
- **4.3** Under the terms of Article 124, No 1 c) and e) of the Code of Administrative Procedure, interested parties will not be heard in advance.

5. Application period:

26 to 30 September 2016

- **5.1.** Applications should be made exclusively via Internet, at the following address: http://paco.ua.pt.
- **5.2.** Applicants may apply to several study cycles and/or several branches / profiles / specialisations of the same study cycle (maximum 6) within the same procedure, indicating the order of preference for each one;
- **5.3.** Independent applications to branches / profiles / specialisations of the same study cycle only occurs when

applicants are selected independently for each branch / profile /specialisation.

- **5.4.** The documents necessary for the processing of applications, considered obligatory those indicated below, with the exception of 5.2.4:
 - **5.4.1.** Photocopy of Identity Card, Residence Permit, or other identification document in the case of foreign applicants:
 - **5.4.2.** Certificate of qualifications indicating the degree held by the applicant;
 - **5.4.3.** Certificate of the disciplines of the study programme completed by the applicant as well as the grades awarded and the respective credits;
 - **5.4.4.** Other documents which the applicant considers relevant for the assessment of the merit of his or her curriculum.
- **5.5.** The application process is conducted exclusively via the upload of the required documents (students with prior qualifications from the University of Aveiro are not required to upload documents relating to the certification of their qualifications and disciplines). Delivery of the original documents may be required at any moment for verification purposes.

In the case of qualifications awarded abroad, the documents should be authenticated by the official educational body of the respective country and recognised by the diplomatic authorities, or Portuguese consular authorities, or carry the apostille of the Hague Convention. The same applies to translations of documents not originally written in Spanish, French or English (translation into one of these languages is obligatory).

- **5.6** In the event that a complaint has been made and a previously "not admitted" applicant comes to be "admitted", they will have the right to admission and an additional place will be made available.
- **5.7.** Notifications related to this procedure will be sent to applicants at the email address given at the time of application.
- **6. Payment**: The fee for application is 20Euros (non-refundable); this fee covers the cost of the six possible choices. Payment should be made using the means of payment available on the application platform. If the applicant is unable to complete their payment using these means, they may do so by sending by post proof of application and cheque or postal order made out to the Universidade de Aveiro, to the Serviços de Gestão Académica, Campus Universitário de Santiago, 3810-193 Aveiro, Portugal, before the deadline for payment indicated on the proof of application. Applications will only be considered valid when payment is made within the established deadline.
